It is more effective to ship wine that is produced in the region of Mendoza, Argentina through ports in Chile, such as San Antonio or Valparaiso. This provides a shorter inland transportation time to the consolidation port of loading as compared to the Buenos Aires port. Argentinean LCL wines are packed at the JF Hillebrand Chile LCL Platform in San Antonio, Chile. A number of trades are served from the ports in Chile with faster vessel transit times, which contributes to an even better LCL service.
